Past Master Highlight

Aylmer Keith P.M. 1848, 1849, 1850

Aylmer Keith was born February 16, 1802 in Rome, Oneida County, New York.

In 1821, he served as Second Lieutenant in the Eighth Regiment of Artillery for Oneida County, New York.

He was a member of Fire Company No. 2, in Rome, New York, in 1826.

He married Eliza Dennison Wylie in New York State about 1830 and they had two children, Aylmer Dennison and?

While in Rome, he operated a grocery store. He also served as Treasurer of the Village of Mount Morris, New York.

About 1840, he moved with his family to Naperville. Shortly after Eliza passed away. He

married Janette Wright and from this union they had five children, William H., Julia M., Edwin, Franklin and Mary.

While a resident of Naperville, he was a merchant, druggist and banker. He was also one of the original investors in the Plank Road that was built from Naperville to Chicago.

He helped form the Methodist Society and was appointed the Secretary and served on the Executive Committee of the DuPage County Bible Society in 1841.

He was appointed Clerk of the DuPage County Society for Mutual Protection in 1841.

He served as a delegate to the Chicago River and Harbor Convention, July 5th, 6th, and 7th, 1847.

He was appointed as Director of the Merchants and Mechanics Bank of Chicago in 1851.

On February 2, 1852 he was Appointed as Naperville Postmaster.

A Charter member of Euclid Lodge No.65 and first Worshipful Master, he also served as Chaplain in 1851, Secretary in 1852, and Junior Steward in 1853.

He was also a charter member and past High Priest (1851, 1852, 1853, and 1855) of Euclid Chapter No.13, Royal Arch Masons.

He died November 15, 1855, in Naperville, DuPage County, Illinois.
