Past Master Highlight Milton Skinner Ellsworth 1867, 1868

Born September 8, 1829 in ating. Troy, Rensselaer County, New York, his parents being Lewis (PM 1853) and Chloe M. Ellsworth.

He was one of the earliest settlers of the county, having come West to Naperville in October, 1837 with his parents.

After completing his common-school education, he attended the Rock River Seminary, at Mt. Morris, III., pursuing his studies there for a year and a half. He then clerked in his father's store at Naperville, and afterwards went into partnership with him in the nursery business.

He was married to Jane E. Barber, May 22, 1854, the Reverend Hope Brown offici-

They had twins, Lewis and Carrie, born June 23, 1857.

He was for many years his father's assistant in managing the famous DuPage County Nursery, then the largest and most thoroughly equipped enterprise of the kind west of Ohio. He was also his assistant during the years of his incumbency of the office of Internal Revenue Collector of this district.

Elected to the responsible position of County Clerk of DuPage County in December, 1877, he was successively elected to that office for five terms, dving while an incumbent of it.

He was a member of the Congregational Church.

In politics he was an active and pronounced Republican from the inception of the party.

He also served Euclid Lodge as Treasurer. in 1869 and 1870, Secretary, in 1853, Senior Warden, in 1871 and 1872, Junior Warden, in 1866. Senior Deacon. 1856. 1857, 1865, 1876, and 1877 and Senior Steward, in 1873 and 1874.

He served as High Priest of Euclid Chapter No. 13, R.A.M. in 1871, and also as King, Captain of the Host, Principal Sojourner ,Royal Arch Captain, and Master of the 2nd Veil.

Died May 26, 1896 in Wheaton, DuPage County, Illinois.



<u>ILLINOIS MASONIC</u> <u>ACADEMIC BOWL</u> What is it? How does it work?

What is the Illinois Masonic Academic Bowl?

The Illinois Masonic Academic Bowl is an academic knowledge competition between Illinois high school scholastic bowl teams. This is an annual tournament sponsored by the Masons of Illinois and is coordinated through the Grand Lodge of Ancient Free and Accepted Masons of the State of Illinois. The goal is to **provide positive recognition for academic excellence**.

What is high school "Scholastic Bowl"?

Two teams compete against each other by vocally answering questions within a specific time limit. Questions are on subjects typically taught in Illinois high schools. The areas of subject matter covered by the questions include **mathematics** (algebra, geometry, trigonometry, calculus, analytical geometry, computers, and general math), **science** (biology, chemistry, physics, astronomy, earth science, and general science), **social studies** (government, geography, history, economics, psychology, philosophy, sociology, and current events), **literature and language arts** (literature, mythology, journalism, grammar, speech, spelling, and vocabulary), **arts** (art, music, dance, theater, and architecture), and **miscellaneous** (sports, business, agriculture, home economics, pop culture, driver's education, consumer education, and industrial arts). A competition match consists of 20 "toss-up" questions with their associated "bonus questions."

How are the individual Masonic Lodges involved?

All Masonic Lodges in the state of Illinois are asked to sponsor a high school scholastic bowl team in our tournament. The cost of sponsoring a team is \$150, payable to the Grand Lodge of Illinois. A Lodge may sponsor one school, or more than one school, or share the sponsorship of a school with another Lodge. Some Lodges may not desire to sponsor a specific school, but may wish to make a general donation to this Grand Lodge program.

Masonic Lodges desiring to sponsor a high school should personally contact the Scholastic Bowl Coach at the school to determine the school's desire to compete in our tournament. The Lodge may NOT enter the school in our tournament, as the Scholastic Bowl Coach must submit their own entry information to the Tournament Director. Lodges are encouraged to make plans for some of their members to be present at the tournament site on the day of the competition to support their school's team.

Euclid Lodge No. 65 has sponsored the Scholastic Team from Naperville North High School again this year.

The Regional Competition will be held on Saturday, February 21, 2009, 9:00 a.m. at the Wheaton Warrenville High School. **All Brothers are encouraged to attend and show their support for this worthwhile endeavor.**

The Four Degrees of Royal Arch Masonry

Mark Master Degree

The First Degree of Royal Arch Masonry is based upon the tradition of an organization of the Operative Masons who were employed on the Temple at Jerusalem by means of which disorder and confusion were avoided. In symbolic signification, it directs the Fellow-Craft to the inculcations of order, regularity, and discipline; it teaches us that the discharge of all the duties of our several positions and stations in life should be discharged with precision and punctuality; that the work of our hands and the thoughts of our hearts should be good and true - not unfinished and imperfect, not sinful and defective - but such as the Great Overseer and Judge of heaven and earth may see fit to approve. Just as the Fellow-Craft Degree is devoted to the inculcation of learning, so the Mark Master Degree instructs us how that learning can be most judiciously and usefully employed for our own honor and the profit of others. Having been taught the duty of discharging all the duties of life, we are now instructed in the importance of performing them with systematic regularity. The goal of every true Mark Master is so to live and work that he may receive at the conclusion of his services that welcome plaudit, "Well done, thou good and faithful servant; thou hast been faithful over a few things, I will make thee ruler over many things: Enter thou into the joy of thy Lord.

Past Master Degree

This Second Degree of Royal Arch Masonry was originally an honorary Degree conferred upon the Master of a Lodge at his installation by three or more Past Masters. In the Royal Arch, it has no historic or direct connection with the preceding Degree, nor with the Degrees which follow. The brief Ritual is not especially significant in the advancement of initiates in Royal Arch Masonry, but it is regarded as necessary. For those who have not served as a Master of a Blue Lodge, a ceremony of investiture is given.

Most Excellent Master Degree

This Third Degree of Royal Arch Masonry is based upon certain historic facts and legends with reference to the dedication of the Temple by King Solomon. The presiding officer represents King Solomon under the title of Most Excellent. The officers are the same as in a Symbolic Lodge, although there are some Rituals in which the Junior Warden is omitted. The symbols, the lessons drawn from them, and the lectures combine as meaningful sequels to certain important parts of Blue Lodge Masonry. They implement much of the instruction previously received and enforce some of the sublimest lessons already given.

Royal Arch Degree

In this degree the climax of Royal Arch Masonry is attained; it is the cope-stone of the Third Degree of Blue Lodge Masonry, the completion of a branch of Masonry that profoundly illuminates all that has gone before. The work of this Degree has close connections with the First and Third Degrees of Chapter Masonry, and reinforces the lessons taught. Much is here supplied for practical guidance for following the tenets of Masonry in daily life.



Could Rosslyn Be The Link?

Rosslyn Chapel has been called a hallucination in stone. John Knox considered Rosslyn as a gaudy Catholic church and a monument to idolatry. The symbolism on its walls has been an enigma to esoteric Masonic historians and scholars for years.

The Chapel was built between 1446 and 1484 as the Collegiate Chapel of St. Matthew. It was built by Sir William St. Clair. He was a descendant of Norwegian nobility settling in Saint-Clair-sur-Epte, in Normandy, about 900 A.D. They came with William the Conqueror, to whom they were related, during the Norman conquest. After the War of the Roses, they moved to Scotland becoming wealthy and influential, immortalized by Sir Walter Scott in his poem, "The Lay of the Last Minstrel."

St. Clairs fought in the Crusades, one of them being the ninth Knights to join Hugh de Payen when he formed the Knights of the Temple in 1118. Sir William carried the Templar heritage over when building the Chapel. It is evident from the many stone carvings on the walls of the Crusaders and Templars, as well as hints of the earlier Celtic heritage.

Significant to either a 32nd Degree Mason or Templar, is the curious inscription on a lintel - "Wine is Strong, the King is stronger, women are strongest, but TRUTH conquers all". This quotation is from the apocryphal book of "Esdras", one of the books rejected for the Bible at the Council of Nicea about 317 A.D.

The Chapel is located on the ledge of a bluff overlooking the North Esk river, a few miles south of Edinburgh. The name of the town, Rosslyn, nearby, is interestingly explained in Dan Brown's book, "The DaVinci Code". The Saint Clair castle was destroyed when Cromwell plundered the area in 1650, sparing the Chapel. The Gothic Catholic Chapel is traditionally situated East and West. The altar being a three step dais at the East. The barrel vaulted roof, all of stone, is supported by seven pillars on each side. The two pillars on columns, to either side in the East are ornately carved to represent Boaz and Jachin, suggesting a Masonic legend. On the walls is a abundance of vegetation and the little green men. This would appear Celtic when nature was worshipped. Did the working Masons here express a desire popular with the Scots, to return to their Celtic origins, which had been nonexistent for 150 years? William of Orange restored the Chapel in 1688 as a Protestant.

Carvings of Mother Mary and Child, and of the crucifixion are evident. Also interesting is a young man kneeling with a rope around his neck, before a monk who has his right hand on the top of the head of the penitent Pilgrim. Next is a carving of a pilgrim warrior kneeling before his sword at Order. Following is a Knight kneeling before the Prior who is knighting him on the shoulder with the sword. These represent the three stages to become a Templar.

I was privileged as Grand Representative of Illinois, in 2000 to attend the Grand Royal Order of Scotland assembly, and the Grand Chapter Convocation of Royal Arch Masons of Scotland. During my stay the Grand Secretary of the Chapter and his wife took me out to Rosslyn Chapel for an illuminating day.

Freemasonry - How Old?

No one knows where or when Freemasonry began. Various authors in different ages have vainly tried to trace Freemasonry back to its origin. However, ancient signs and symbols, and ancient structures give indisputable evidence that Freemasonry existed many centuries before any written history was recorded.

The Pyramids and the Sphinx of Egypt, for example, constructed some 2200 years before the birth of Christ, yield conclusive evidence of Freemasonry, and relics from the ancient Aryan race lead one to believe that Freemasonry existed in Egypt over 4000 years B.C. Then, go to the pyramids of Central America, which scientists claim were built around ten thousand years ago, and there, carved in their inner walls of solid stone you will find the Signs and Symbols of Freemasonry.

Such evidence would lead a thinking person to wonder if they were not built by Ancient Operative Masons.
