They had many introductions of dignitaries and greetings from different Lodges and constitutions, which was really interesting. I presented the Worshipful Master with our "Euclid Lodge" 150 year anniversary pin.

My experiences travelling to different lodoes and different countries made me realize how wonderful the universality of our fraternity really is. Loaves and Fishes

Loaves and Fishes Community Pantry was founded in 1984 for the purpose and mission of providing food and other essentials to Naperville residents in need.

Last year 2,000,000 pounds of food and groceries were distributed to 2,295 unique struggling families. In February, Loaves and Fishes distributed food to 4,720 people, helped 286 single moms feed their families, and provided food to 620 seniors and 1819 children.

Volunteers from Euclid Lodge helped with the distribution of food to our communities needy on Saturday, April 2, at the Loaves and Fishes Food Pantry, 1871 High Grove Lane, Naperville.

This is a monthly event for the Lodge. The first Saturday of each month has been designated as our day to help out. There are two sessions: 7:30 a.m. to 10:30 a.m. and 9:30 a.m. to 12:30 p.m.

If you have a couple of hours to spare on May 7 and you would like to be more involved with our community, please come out and lend a hand.

Past Master Highlight Sankey S. Good 1916

Sankey S. Good was born May 23, 1886 in Bernadotte, Fulton County, Illinois, the twin son of Daniel P. Good and Clara Manbeck. Moody M. Good his twin brother, was also a member of Euclid Lodge.

He married Evelyn Thornton on October 25, 1919 in Columbus, Georgia, They had one child, a daughter, Emily Ann.

He served as a Seaman in the U.S. Navy from 1904 until 1917. October 24, 1917, he enlisted in the U.S. Army as a private in Headquarters Company Infantry School and received his discharge February 7, 1919.

He was then employed by the U. S. Postal Service, first as a clerk, then Assistant Post Master, and finally as Postmaster, from 1927 to 1932.

He was a member of the American Legion, Post No. 43; Independent Order of Odd Fellows Naperville Lodge No. 81; and Floral Rebekah Lodge No. 265.

He also served Euclid Lodge as Senior Warden in 1915, Junior Warden in 1914, Junior Deacon in 1913, Junior Steward in 1912, Marshall in 1917 and Chaplain in 1921..

He served Euclid Chapter No. 13, R.A.M. as High Priest in 1920.

He died April 19, 1936 in Naperville, DuPage County, Illinois. Funeral services were held at the Arthur R. Beidelman Funeral Chapel, under the auspices of Euclid Lodge No. 65. Rev. Dewey R.

Eder officiated and the Oriental Masonic quartette furnished the music. Interment was made in the Naperville Cemetery.

The Philosophy of Freemasonry

Freemasonry is one of the world's oldest secular fraternal societies. It is a world wide organization based on the principle of 'Fatherhood of God and the Brotherhood of Man'. It is a society concerned with moral and spiritual values. Its precepts are taught, by a series of rituals, which follow ancient forms and stonemasons' customs, tools and allegorical guides. Its avowed objective is to make good men better.

The public does not know much about what Freemasonry is and what Freemasons stand for and from what little is known, it is often mistaken as a secret society. Freemasonry has nothing secret or secretive, as it does not conceal the time and place of its meetings, nor do its members hide their membership. As a universal organization, it has modes of recognition, which are of interest only to Freemasons and are not therefore revealed to nonmasons. They are thus no different from the passwords prevalent among Internet and credit card users, to prevent misuse and frauds.

The universal symbol of Freemasonry, are the Square and Compasses. As non-operative, but speculative, or figurative masons, the working tools used by masons, for construction of buildings, are applied by Freemasons to their morals. Thus the Square used to prove right angles, symbolizes the square conduct expected to be followed by Freemasons at all times and the Compasses, which are used to measure the limits and proportions of the plan of the building, represent the limits of good and evil within which Freemasons are always expected to act. Likewise, the plumb line, which is used to prove uprights and perpendiculars, is symbolic of the uprightness of actions to be borne in mind by Freemasons at all times, while the level used to prove horizontals, represents equality. Other working tools also teach similar moral lessons.

The universal motto of Freemasonry is "Brotherly Love, Relief and Truth". Charity is the predominant characteristic of every Freemason's heart. Freemasonry teaches the practice of the moral virtues of Temperance, Fortitude, Prudence and Justice as well as that of Faith, Hope and Charity. Virtue, Honor and Mercy are its distinguishing aspects. It is committed to extend the hand of fellowship and providing relief to those in distress. It inculcates obedience to God and observance of the laws of the country.

Freemasonry is not a religion, but it emphasizes secularism through respect and tolerance for all religions and a belief in a Supreme Being without reference to caste, creed, race, or religion. It is not a social club; it consists of a cross section of society, who meet and socialize on an equal footing; it also involves family members on social occasions. Any one who is above twenty-one years and has a belief in a Supreme Being can become a Freemason.

Throughout the world, Freemasons are engaged in many philanthropic and charitable projects. Such projects in India include, a Masonic Poly Clinic and Public School as well as a school for Spastic Children at Delhi, a Children's Masonic Medical Centre in Coimbatore, adoption of an entire village for all round development in Visakhapatnam district, providing of shoes for cyclone victims, in Andhra Pradesh, an Orphanage for children who lost their parents in Tsunami at Karaikal, a Community Centre by way of Tsunami relief in Kanyakumari district, Dhanya dhan and Ghyan dhan projects, bursaries and scholarships, helping institutions for the handicapped and aged and holding of periodical blood donation, eye and other health camps in different parts of the country.

Prominent Freemasons in India include Swami Vivekanada, Moti Lal Nehru, C. Rajagopalachari, Fakhrudin Ali Ahmed, as also serving and retired Judges of the Supreme Court and the High Courts, serving and retired Defense Services and Civilian Personnel, besides many Industrialists, Business men and executives and other professionals.

To sum up, Freemasonry is a Way of Life which is intended to improve the personality of every one of its members.



"Free" Masons

There have been many explanations as to how the term "Free" came to be applied to Masons. Operative Masons frequently were free of local laws. In some cases they were free from taxes. Their actions were not restricted as were the actions of others. They were free to travel from country to country in following their trade or art. Masons who labored on Solomon's Temple, legend tells us, enjoyed special privileges and were free from laws others were required to obey.

In modern days, however, it seems some feel the term means free from attending Lodge, free from calling on the sick, free from obligations voluntarily assumed, free from giving aid to the officers, free from taking any part in the work, free from any responsibility, free with criticism.

Let us be the kind who *do not wait for free time* in which to attend Lodge. Let us not be the kind who believe *Free*masonry is *free*. We are free to do as we wish about these things, but *no one can be a Freemason* in the true and fullest sense of the word *unless he purchases that Freemasonry with his time*, with his energy and by use of the faculties wherewith God has blessed him.
