In Memoriam Charles Lloyd Calderwood

Once again, a Brother Mason, having completed the designs laid down on life's Trestleboard, and having answered the last summons of the Grand Warden of Heaven, has now entered the Celestial Lodge above, over which the Supreme Architect of the Universe presides.

Brother Charles Lloyd Calderwood was born July 22, 1922 at Chicago, Illinois.

He was elected February 23, 1953. Initiated an Entered Apprentice March 16, 1953, Passed to the degree of Fellowcraft April 20, 1953 and Raised to the Sublime Degree of Master Mason May 23, 1953 in Lawn Lodge No. 815, Chicago, Illinois.

He affiliated with Euclid Lodge No. 65 in Naperville, Illinois on March 8, 1965. He served as Master of Euclid Lodge in 1972 and 1976. He was a member of Euclid Chapter No. 13, Royal Arch Masons in Naperville, Illinois and served as High Priest in 1992 and 1993.

He affiliated plural with Oconomowoc Lodge No. 42 in Oconomowoc, Wisconsin September 22, 1994. He was called from his labors on earth to Eternal Refreshment in the Paradise of God December 28, 2011 at Oconomowoc, Wisconsin.

Thus ends the Masonic Record of this just and upright Mason.

Past Master Highlight Herman Charles Hageman 1927, 1930

Herman Charles Hageman was born May 8, 1884 in Naperville, DuPage County, Illinois the son of Charles Hageman and Fredericka Miller. He married Lillian Rebecca Kroehler June 22, 1910 and they had five children, Ruth Ann Louisa, Virginia Catherine Cleopatra, Grace Fredericka Irene, George Herman Charles Sr. and Albert Charles.

He attended the Naperville schools and at the age of fourteen went to work at the Naperville Lounge Factory. He became an electrician there and worked there until his death except for a few months when he went to work for the Western United Gas Company in Downers Grove. He ran unsuccessfully for Naperville Village Alderman.

He was raised a Master Mason April 12, 1922 in Euclid Lodge and served as Master of the Lodge in 1927 and again in 1930. He was also a member of Euclid Chapter No. 13, Royal Arch Masons, Aurora Commandery No. 22 and the Shrine. He died November 10, 1944 in Naperville, DuPage County, Illinois and was buried in the Naperville Cemetery with the Masonic Funeral ritual performed by members of Euclid Lodge and Noble Harvey as Reader.

Euclid Chapter No. 13 Royal Arch Masons



As Master Masons, one of the duties we are required to perform is that of balloting on candidates. This is a duty that continues into the appended bodies of Masonry, in which case we find ourselves balloting on fellow Master Masons. While the natural assumption may be that this is just a formality it is, in fact, often times a more difficult proposition than balloting on a candidate for initiation into Blue Lodge. It is important to be very thoughtful and deliberate in performing our Masonic duty in balloting, but we should also be well aware that there exists no ballot box that contains only white balls. The black balls (cubes) are always present to remind us that, if our true goal be a stronger and more faithful fraternity, the black ball *must* be cast from time to time. If we follow the instruction given prior to casting our ballot that reminds us to "vote for the good of Masonry and for this Lodge (Chapter, Council, etc.) in particular", we can be at ease with whatever ball, black or white, our duty requires us to cast. Thankfully, the issue is seldom brought into play, but I felt it was worth delving into for new and old Master Masons alike.

I came across the following and thought it offered a very good explanation:

The brother who casts a cube then wields great power. Like most powers, it can be used for good or ill. It may work harm, or good, not only on applicant, but also to he who uses it. No brother or officer can interfere with the use of the cube and only the brother knows why it was cast. The very absence of any responsibility to man or authority is one of the reasons why the power should be used with intelligence, and only when, after solemn self-inquiry, the reason behind its use is found to be Masonic. There are hundreds of good reasons for casting of a black cube. If the lodge might suffer, or if a brother might suffer from the applicant being accepted, then we have reason for seeing that he is rejected. Such use of the cube is proper, Masonic, ethical, wise, just. No hard and fast rule stands true. There is no way to explain "a good reason, bad reason" for casting a black cube. Each has to judge the reason for himself.

Some suggestions may be given. We know a man we dislike. He has different ideas from ours. Our dislike does not amount to hatred, nor is it predicated on his character. We just rub each other the wrong way. When he applies to our lodge we must make a decision: will our differences be greater than the good that might come from his reception? Are we sure that we cannot accept him as a brother merely because we "have never liked him?" The un-Masonic use of the cube is a misuse of power. Turning the cube into a secret dagger for personal revenge is indefensible. The black cube is our protection of the Fraternity. But at the same time it puts to the test the Masonic heart, and the personal honesty of every brother. The cube is a **test** of our understanding of the Masonic teaching of the cardinal virtue, Justice.

We teach of justice that "it should be the invariable practice of every Mason, never to deviate from the minutest principles thereof." Justice to the lodge requires us to cast the black cube on an applicant we believe to be **unfit**. Justice to ourselves requires that we cast the black cube on the application of the man we believe would destroy the harmony of our lodge. In justice to the applicant, we are taught to render justice to every man, not merely to Masons, justice requires that no black cube be cast for petty reasons, meanness, or revenge. No man knows what we do; no eye will see, save that All Seeing Eye which pervades the innermost recesses of our hearts, and will reward us according to our merits. The black cube is a great strength to protect Freemasonry. Used thoughtlessly, carelessly, without Masonic reason, it harms not only he whom it was used against but he who used it. A well used black cube goes into the ballot. Ill used, it drops into the heart and blackens it.
